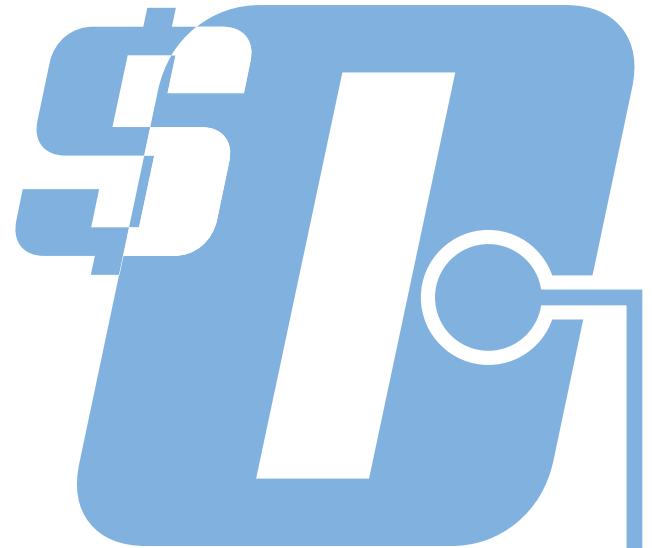

FlexFee Program

Polaris starts with a full service program and a very competitive management fee, then works with you to make that fee disappear. Aircraft charter activities typically result in you splitting the proceeds 85% / 15%, with 15% going to the charter operator, in addition to the annual management fee. When you let Polaris manage your aircraft you still get 85% of the charter proceeds, but for each charter hour flown Polaris will reduce your fixed annual management fee, with the ability to bring that fee all the way down to \$0.

Fuel Savings

In addition to our leading edge FlexFee Program, Polaris offers a fuel management solution that is second-to-none. With over 1,000,000 gallons purchased annually across our fleet of Boeing, Gulfstream, and other aircraft types, our average global price per gallon typically sits below \$3.55, with a domestic average as low as \$1.98. At Polaris you get the buying power of a large fleet, no matter what aircraft you operate.



Phenom 300 Example

Client X owns an Embraer Phenom 300 aircraft with excess capacity of 200 hours; the average hourly charter rate is \$5,000/hour, where the client receives 85% of that rate as income, and 15% is paid to the operator. Save \$135,000 with Polaris!
